Charges: Federal Indictment/Conspiracy to Distribute Cocaine Base



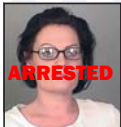

Charges: Probation Violation (POSS. COCAINE)



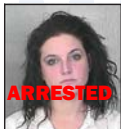

Charges: Probation Violation (POSS. COCAINE)



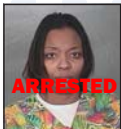
